Boston Health Care for the Homeless Program (BHCHP) is a nonprofit organization that provides or assures access to the highest quality healthcare for all homeless men, women and children in the greater Boston area.

BHCHP's integrated care model unites physicians, PAs, nurse practitioners, nurses, case managers and behavioral health professionals in a close collaboration. They follow patients together and separately in a variety of settings: on the street, in medical respite care, in outpatient clinics and in shelters and housing. BHCHP's senior staff members include Melinda Thomas, PA-C, associate medical director, and Carole Hohl, PA-C, director of HIV services. In 2013, BHCHP served more than 12,000 patients in more than 90,000 outpatient medical, oral health and behavioral health encounters.
